
#### Rosson's Roundup

They are all doing well, enjoying their new roles and responsibilities, and excited about getting back to Aggieland in the fall. Interns are working on the House Agriculture Committee, for Representatives Brady, Carter, Cuellar, Sessions and Vela, and serving with the Foreign Agricultural Service and the National Association of State Departments of Agriculture.

This Wednesday, Tiffany Dowell and I attended a meeting at the Texas A&M School of Law, meeting with Maxine Harrington, Associate Dean for Academic Programs and Aric Short, Vice Dean. We discussed several ways to enrich the experiences for students. In the near term, it's most likely the Law School will offer two survey courses with topics including energy, natural resources and environment law, and business organization, entrepreneurship, finance and real estate. For the longer term, we discussed the possibility of student and faculty exchanges, certificates in areas such as rural law, and a 3+3 program in which our students would complete a law degree at Texas A&M School of Law. We agreed it best to begin with a couple of courses, assess student interest, and then pursue more in-depth engagement. We also received a tour of the building where the law school is located, right across the street from the Convention Center. It's a great facility, with large classrooms, an auditorium, moot court rooms, and an excellent law library. They also have their own bookstore, with lots of Texas A&M School of Law items, such as shirts, caps, mugs, pullovers and ties. They have made a very quick transition to Texas A&M and their enrollment is up 25% this fall, approaching 750 students.

I'm off to AAEA in Minneapolis tomorrow, and hope to see many of you, and our students there. We have two Academic Bowl teams competing, so I'm very much looking forward to their success.
