This week has been busy with preparation for the fall semester well underway. Wednesday I met with our last group of transfer students and some of their parents. Aside from stressing the importance of academics and managing their time, I emphasized the importance of living the Core Values of Texas A&M: Excellence, Integrity, Leadership, Loyalty, Respect and Self-Less Service. I really wanted the students to understand that these values are not simply words on a slide, but guidelines for life at Texas A&M and more importantly, life after Texas A&M. I also mentioned that the Department will be hosting two tailgates: Ball State (September 12) and the University of South Carolina (October 31). Finally, I passed along a message to the parents to let them know that we value the trust they have placed in us to prepare their children for careers in their chosen areas, we are a 'transfer friendly' department and we are here to help in whatever capacity we can. I believe the message was well received.

Thursday, I traveled to Houston with Patrick Williams and Jon Rigelsky to visit with Ken Hogan, one of our former students, a Senior Vice President and Head of Foreign Exchange for Cadence Bank. Ken took us through his trading floor with real-time currency quotes and the capability to pull up historical comparisons on the 'big screen' (52 inch), and do analysis on the spot. We discussed how we might try to get something like this in the Department at some point, but in the meantime, Ken offered to have some of our students visit his facility this fall and to consider conducting a currency analysis and trading internship program during the winter break. I'm going to explore doing both of these, and hope we can do them this next semester.

Saturday, Texas A&M AgriLife Research is holding its strategic planning workshop at the College Station Hilton. The Vice Chancellors Office, Department Heads and Directors of the Research and Extension Centers will attend. Our main task will be to conduct a SWOT analysis of the agency and to then formulate that into action items for the strategic plan. I'll share this with you as it comes together later this fall.
