

Open Rank Faculty Position, Department of Agricultural and Applied Economics, The University of Georgia. Full time, tenure track, 9 month appointment, research/teaching. The Department seeks an economist in the fields of: 1) international development; 2) natural resource/environmental economics; and(or) 3) international trade. A Ph.D. in Agricultural Economics, Applied Economics, or Economics is required with strong foundation in economic theory and quantitative methods. Forest Taxation and Economics Outreach Specialist, Warnell School of Forestry & Natural Resources, University of Georgia. This is a 12-month, 75% outreach, 25% research appointment offered at the rank of Public Service Assistant. The successful candidate will be expected to develop an active outreach program supported by extramural funding to deliver relevant and current science, policy, and literature-based forest taxation and economics information to the state and region. Applicants should hold a graduate or professional degree (MS/MF/MFR/MBA/JD/PhD) beyond the bachelor's level with a focus in forest taxation, forest economics, forest management, accounting, agricultural economics, business, or a closely related quantitative area of study. To ensure full consideration, candidates must submit a PDF file including a cover letter, curriculum vitae, statement of outreach and research interests and experience, and a PDF file including unofficial transcripts of all college-level work, copies of up to three recent publications, and contact information for three references by **December 15, 2015**. Individuals selected for our short list will be required to submit official college transcripts and three letters of reference. University policy requires all candidates to consent to a background investigation (www.hr.uga.edu). Finalists will be required to provide a signed consent form authorizing the University of Georgia to conduct a background check. The background investigation will be conducted on a post offer/pre-employment basis.
