Finally, I'd like to provide a brief update on our Master of Agribusiness program. Fall 2015 is shaping up to be the beginning of an excellent academic year. The incoming MAB class is anticipating 23 new students, which will bring total enrollment for the program to 50. This is 22 percent more than last year, and there are five more students who may enroll as well. The composition of the MAB continues to diversify, with 48 percent female and 42 percent international students. Four MAB students received COALS Fellowships for early enrollment. In addition, 22 of the 27 first year MAB students are either doing internships or employed this summer, so our placement was excellent. Thanks to Vicky Salin, Jennifer Newsom, the Graduate Office and the members of the Intercollegiate Faculty of Agribusiness (IFA) for your efforts!
