Position Title: Assistant/Associate Professor and Extension Specialist, Economist-Management, District 1, Amarillo, Texas

Appointment: 100% Extension (Texas A&M AgriLife Extension Service) in the Department of Agricultural Economics. This is a permanent, full time, non-tenure track position

General Duties and Responsibilities: Responsibilities involve district leadership and coordination for Extension education programs and applied research in management, marketing, finance, resources, and policy by providing technical expertise and educational program development for industry audiences such as farmers and ranchers, merchandisers, processors, lenders, and users. Other relevant audiences include trade associations, media, and federal and state employees working with these Texas audiences. Overall responsibilities require individual and team efforts to plan, develop, implement and evaluate curricula, extension education programs, and applied research related to production economics, marketing, finance, risk management, technology transfer, analysis of economic choices and impacts, and other issues facing crop and livestock producers and other industry clientele. Given the geographic location of this position, there is an expectation of a strong emphasis dealing with a diverse set of crops, livestock, water/irrigation and related issues. Educational program delivery will include Extension and other peer reviewed publications, workshops, conferences, computer and web based software, electronic and mass media, and social media releases. The individual also will be responsible for developing grant & contract proposals where appropriate to support the applied research and Extension efforts for the position. The successful candidate will be expected to cooperate with Campus and other District based Extension/Research Faculty, District Extension Administrators, County Extension Agents, Regional Program Leaders, and other Specialists, as necessary in developing and delivering nationally recognized programs for Extension faculty and clientele. Travel in- and out-of-state is necessary to fulfill job responsibilities.

Qualifications: A Ph.D. degree, either completed, or all but dissertation in Agricultural Economics or closely related field along with coursework in one or more of the following areas; farm and ranch management, agricultural finance, marketing, policy, and risk management is required. Preference will be given to candidates with experience in extension, research, or similar work within the agriculture industry and a demonstrated ability to communicate effectively, cooperate as a team member, lead applied research efforts, and demonstrate a willingness to be heavily involved in outreach education with constituency groups.
